During previous Budget, Finance and Operations Committee meetings (most recently July 31, 2017) it was discussed whether fees and hours of operation at the Center should be adjusted. As part of that meeting there was discussion regarding having a Market Analysis performed.

Staff is in the process of obtaining cost estimates for the Market Analysis based on the following criteria.

- Evaluation of current operations
- Review current programs, activities and services
- Market Analysis for pricing structure for memberships and services
- Local demographic/statistical data
- Membership assessment
- Strategic marketing plan
- Equipment and space analysis
- Current financial performance.

Scope of work will be provided to professional consulting services organizations to obtain cost estimates (attached).
