This request is for equipment upfitting of six (6) 2019 Ford Interceptor marked police vehicles. In accordance with City of Maricopa, Purchasing Code, Article IV, Section 3-223, Cooperative Purchasing, it is recommended that the City of Chandler Cooperative Contract #PD8-055-3838 be utilized to purchase this equipment upfitting. This contract was competitively solicited and awarded to Arizona Emergency products effective december 1, 2017 and runs through November 30, 2020. Total amount not to exceed \$89,856.27.
