The Mayor and City Council shall discuss and possibly take action to approve Ordinance 21-06, a request by Sandbox Development Consultants, to amend the designated land use for approximately 18.82 acres of land from Local Business Zone (CB-1) to Multiple Unit Residential Zone (RM) as identified in the City's Zoning Map. Generally located near the southeast corner of Honeycutt Road and Hartman Road, within the City of Maricopa incorporated limits. The land is located in a portion of Section 28 of Township 4 South, Range 4 East of the Gila and Salt River base and meridian, Pinal County, Arizona.

On April 12, 2021 the Planning & Zoning Commission recommended that the City Council approve case # ZON21-01, and adopt Ordinance 21-06.
