The City has received a request by the owner/developer to accept the public improvements and maintenance responsibility for the local internal streets within Tortosa South Subdivision Parcel A; a map showing the specific streets is included with the Resolution as Exhibit A. City staff has performed field inspections to ensure that the improvements have been completed correctly and in accordance with the approved design. These improvements have met the City's requirements for full acceptance.
