The Mayor and City Council shall hold a Public Hearing regarding a request by Alan Beaudoin and Rachel Smith, of Norris Design, on behalf of Shaun Ridge, LLC, to amend the city's General Plan Land Use Map, approximately 20.17 acres, from Employment (E) to High Density Residential (HDR).
